The Clinical Information System (CIS) - .mil enclave is an unclassified commercial off the shelf (COTS) system supporting the delivery of inpatient, emergency department, and selected outpatient care at DoD Military Treatment Facilities (MTFs). Defense Health Agency (DHA) has purchased licenses and is under contract to utilize this COTS product, owned by CliniComp International. DHA operates the system at all sites, with support from CliniComp International. CliniComp International maintains an enclave that connects to sites for support, upgrade and troubleshooting purposes, and serves/acts as a backup copy of Clinical Information System (CIS)/Essentris® Inpatient System data to support the continuity of operations in the event CIS Essentris® is rendered inoperable. Personally identifiable information (PII) may be collected, maintained, processed, or disseminated by systems and applications within the CIS - .mil enclave. PII may include numerous types of PII including employee and beneficiary contact information, military information, demographic information, Social Security Number (SSN), and protected health information (PHI).

PII processed on some system components, applications, and documents might utilize specific administrative, physical, and technical security controls to protect PII confidentiality and which may be addressed in separate PIAs.
