c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The purpose of the Enterprise Blood Management System (EBMS)-Donor, formerly known as Blood Donor Management System (BDMS), is to manage the blood donation aspect of the Armed Services Blood Program (ASBP), including blood donor registration, screening, blood products, and associated record keeping for military blood donors, dependents of military donors, and other civilian donors in the Continental United States (CONUS), Outside the Continental United States (OCONUS), and in Theater. EBMS-Donor is a Commercial off the Shelf (COTS) product manufactured by WellSky® and is FDA Class II regulated. EBMS-Donor replaced the Defense Blood Standard System (DBSS).

EBMS-Donor is accessible to authorized users, including those who may be considered the general public (i.e., government civilians, military, and contractors), from 20 DHA Blood Donor Centers (BDCs) and the 2 Armed Services Whole Blood Processing Laboratories (ASWBPLs). Access to a system hosted web application is restricted to the authorized users previously mentioned, and cannot be accessed by the public at large.

The types of personal information collected in EBMS-Donor includes: contact information, demographic information, Date of Birth (DOB), names, Social Security Number, ID numbers, pertains to blood donations, and employment information. The groups represented in the system for which PII is collected are Service members, Department of Defense (DoD) beneficiaries, Department of Veteran Affairs (VA) patients, civilian patients, and foreign nationals.

EBMS-Donor is owned and managed by the Health Services Support (HSS) Program Management Office (PMO) under the executive management of Defense Health Agency (DHA), DAD IO/J-6, Solution Delivery Division (SDD).

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

PII is used to identify and verify donor demographics in determining donor suitability and used to associate donors to blood collections for the purposes of testing and look-back implications.

Individuals have the opportunity to verbally object to the collection of their PII at the time of blood donation. If individuals choose not to provide their PII at the time of blood donation then they will not be able to donate blood.
